Corporation (NYSE: FNB), today announced that the Office of the Comptroller of the Currency has approved its pending acquisition of 17 branch banking locations in the Pittsburgh MSA from Fifth Third Bank. There are no additional regulatory approvals needed to complete the transaction.

The transaction is scheduled to close in the second quarter of 2016.
